Underlining the Need of Vendor Audits in the World of Supply Chain Operations

It was the June of 2012, and the city of Toronto in Canada was gearing up for a summer concert by the wildly popular British rock band, Radiohead. However, the events took a turn for the worse when the temporary stage constructed for concert collapsed, injuring three members of the crew and killing the drum technician Scott Johnson. And even though it seemed like a comparatively low-damage incident and thus of lesser significance, the case garnered global attention due to the popularity of the band.

Two separate inquests in 2019, in Canada and in the UK, found serious technical flaws with the construction of the stage that alluded to the contractors overlooking critical construction elements and design components. It further ascertained that the project was completed without required and necessary site inspections. In fact, the coroner's exact findings were "inadequate technical advice" and "wholly inadequate construction techniques" that resulted in the incident.¹

The potential consequences of such serious lapses need little explanation. Apart from government enforcement actions that often lead to monetary penalties, the cost of a serious supply chain disruption can also include defamation and suppliers unwillingness to collaborate in future projects. Fallouts are often extensive for larger corporations with diverse suppliers.

In today's fast-paced business environment, suppliers and contractors play a critical role as an extended arm of the hiring organization. They can help companies realize additional value through their specialized skills which may lead to better quality of work. However, working with them also makes businesses susceptible to increased risks such as costly outages arising from the risk of failures, poor quality standards, lack of proper safety control measures and cost containment challenges due to unforeseen/ hidden elements. The longer and more scattered the supply chain, the higher the risk of disruption.

A 2019 survey conducted by Deloitte revealed that over 80% of organizations had experienced a third-party incident in the last three years. Additionally, close to half of those incidents (46%) had a moderate to high business impact that included significant damage to customer service, financial losses, damage to reputation and legal complications arising from a regulatory breach.





While there was no singular reason these incidents occurred, a common underlying factor was the lack of in-depth knowledge about their supply chain. Only about 10% of the surveyed organizations reported having reasonable knowledge and awareness of their subcontractors, inducted by third-party suppliers. Further, of the 10%, only 2% reported comprehensive monitoring of all of their subcontractors.²

This distinct lack of awareness creates a serious risk-factor that can entangle an organization's reputation as well as their future business potential.

While the repercussions of supply chain non-compliance are pretty obvious, many organizations don't take serious actions, monitor, or audit their supply chains. Research reveals that over one-third of firms have no idea about how their suppliers are performing. The main reasons cited by the respondents include lack of technology and time, understaffing and sometimes, not feeling the need to monitor supplier performance.³

Knowing what are the risks of disruption to supply chain continuity, understanding their severity and charting out an effective risk mitigation plan is intrinsic to successful supply chain risk management. How can organizations proactively prevent risk without knowing who their contractors are, where they are located, whether they have the right documentation or if they follow the right compliance measures?

The responsibility of third-party supplier risk management essentially lies with the Chief Risk Officers (CROs) or Chief Compliance Officers (CCOs). However, a third line of defense, supplier audits, can aid in this crucial charge. Regular contractor audits help companies proactively identify risks within the supplier base. In addition, they ensure that proper internal controls are in place and timely risk intelligence is generated to drive informed decision making.





Auditing Suppliers - Why is it Important?

In a competitive world, market reputation can either cement or debase your existence. For vendors, this is seen through winning more projects with regularity. When meticulously designed, an audit program provides a strong competitive advantage for both the suppliers and the hiring organizations.

Improving business operations



Hiring organizations often closely monitor operators' audit results, observing whether they have the right documentation and practices in place. Increasing credibility

Working with unaudited vendors can often turn out to be a cost-intensive affair in the long run. Loss of business, reputation damage, legalities arising from non-regulation & penalties are just some of the risks that come with unverified contractors.

On the other hand, regular supplier audits gives visibility into the strengths and competencies while highlighting any issues or underlying negligence. It provides a fair assessment of the contractor's compliance and gives them the opportunity to adjust to meet client standards rather than just being disregarded when gaps are uncovered.

Auditing vendors have to comply with guidelines such as the "Health and Safety at Work etc. Act 1974", OSHA and other EHS regulations that outline the guidelines for occupational health and safety in the workplace.
